1. Roll Call

6. New Business

a. LM18-000001 – 619 E Avenue A: Request to replace existing porch floor and ceiling with unlike materials.

Barlow provided the staff report. The applicant, Geni and Joe Woody, are requesting to replace their deteriorating wood porch and ceiling with unlike materials. The replacement materials are made from PVC that mimics wood. Barlow said that changing the porch and ceiling does not substantially alter the character or design of the home. He concluded that the Secretary of the Interior's Standards for Rehabilitation were met, and staff recommendeds approval.

Motion by Higgins, seconded by Holmes, approved unanimously, to approve LM18-000001 request for Landmarks Commission approval of the proposed exterior modifications to the house at 619 East Avenue A (replacement of front porch floor and ceiling with unlike materials) based on finding that the project meets the Secretary of the Interior's Standards for Rehabilitation and that the project will not damage or destroy the historic significance of the structure and the Houston Whiteside National Historic District.
